
look forward to their presentation.

General Manager's Report Bill Witbeck

Over the last few months, we have received a number of inquires on whether or not an Auditor's report is required by our member plants. In referencing the new Cooperative Director's Handbook, issued in April 2004 my interpretation was that it was not required. I passed this along to a couple of plants. One plant forwarded the info to their accountant who in turn called me and advised an audit is required. I then contacted Alberta Government Services for clarification. Here is what they said, "regarding the appointment of an auditor, while it could be possible for an auditor to not be appointed for more than one year (reference

sections 235(1), 236 (1) (a) and 236 (2) it would not be good practice for the cooperative to do so and it is not recommended.

Dispensing with an auditor generally is only considered by relatively small cooperatives having little or no financial activity and even then it should only be done cautiously. Cooperatives can, as provided for in section 244, set up an audit committee of at least three committee directors, a majority of who are not full-time officers or employees of the cooperative or its affiliates to undertake a form of audit of the cooperative's books and records.

Requirements set in the Act for Directors to place before the membership at every annual meeting of members, as per section 228 (b), includes the 'report of the auditor, if any'. Again it is prudent that larger cooperatives with substantial financial activity would engage the services of an independent outside auditor. Cooperatives, similar to business operations, need to determine themselves the extent of the audit to be done that would satisfy the needs set out by the members".

Drug Dispensing Fees By Doug Sample, CEBS

Have you ever purchased a drug at one pharmacy, then discovered upon filling the same prescription a few weeks later at a different pharmacy that there is a considerable price difference? The likely culprit is the dispensing fee the pharmacists are levying for their services.

The cost of a prescription drug is made up of the cost of the medication plus the professional fee the pharmacists add for their services. The professional fee is commonly referred to as the dispensing fee.

Dispensing fees in Alberta range from approximately \$5.00 to \$11.50, depending on the pharmacy that fills the prescription. In general, the large "big box" retails such as Costco, Superstore and Wal-Mart have pharmacies that tend to be at the low end of the range while the more traditional drug stores tend to be at the high end. Grocery and department store pharmacies typically fall somewhere in the middle.

Given that the cost of employer sponsored health insurance plans is directly impacted by the dollar value of prescription drug claims, savings as a result of lower dispensing fees can have a significant impact on the cost of these programs over the long term.

By "shopping around", individuals that regularly make prescription drug purchases can assist in reducing the cost of health insurance programs and help sustain their viability into the future.

Foraging Ahead

The forage and turf seed industry is valued at over \$100 million dollars annually in Canada, and this industry is a key component of Alberta agriculture. The winter issue of **seed.ab.ca** will take a look at forage variety selection, helping growers examine the factors to consider when they make their seeding decisions.

Treating Tips & Tricks

Agitation of all seed treatment products whether they are mixed with water or not is always a good idea. Many plants now have systems that are hooked to timers that turn agitations on/off to ensure agitation takes place even when the product is not being used. Care must be taken not to OVER-agitate. Over agitation can result in foaming and in the worst cases, products may sheer; or separate beyond repair to

render them impossible to use.

Faoming on the other hand, creates an unstable formulation, which results in widely variable application rates. Return lines used for agitation, or otherwise are recommended to reach the bottom of the premix tank, to ensure air does not get induced into the formulation.
